1. APOLOGIES: Chris Finbow

- **2. MINUTES OF LAST MEETING:** The minutes of the meeting held on 11 November were agreed and will be signed as a true record.
- 3. MATTERS ARISING: there were none
- **4. TREASURER'S REPORT:** Total funds at the end of 2020 were £15,797. The recently constructed storage shed expenses total £7,772.80 to date there will be some additional expense for the electrics installation. Village Hall electricity payments for 2020 were based on estimates: following Sue's end of year meter reading, we now have a credit of £252.21 on our account. - **6. STORAGE SHED:** The storage shed is complete apart from installation of electricity. Jackie will contact Aaron Nobbs to ask for a quote to connect power to the shed, install a fluorescent light and a double power point. Patrick pointed out that Aaron should be made aware that we intend to line the shed at some point in the future. **ACTION JACKIE.** There are three shed keys: Diane has one and the other two are in the drawer in the kitchen.
- **7. REPAIR AND MAINTENANCE REPORT:** Patrick has turned the water off. The tables and chairs borrowed over the Christmas period by Richard Baker and Deborah Bell have been returned and placed in the centre of the hall.
- **8. HALL REOPENING**: The sub-committee did not meet in early January, as we are no further forward with re-opening. The first possible booking is for elections in May. If the elections take place we will liaise with East Suffolk to ensure safe procedures are in place. John has agreed a £200 booking fee for the election hire.
